### Tax incentives\*

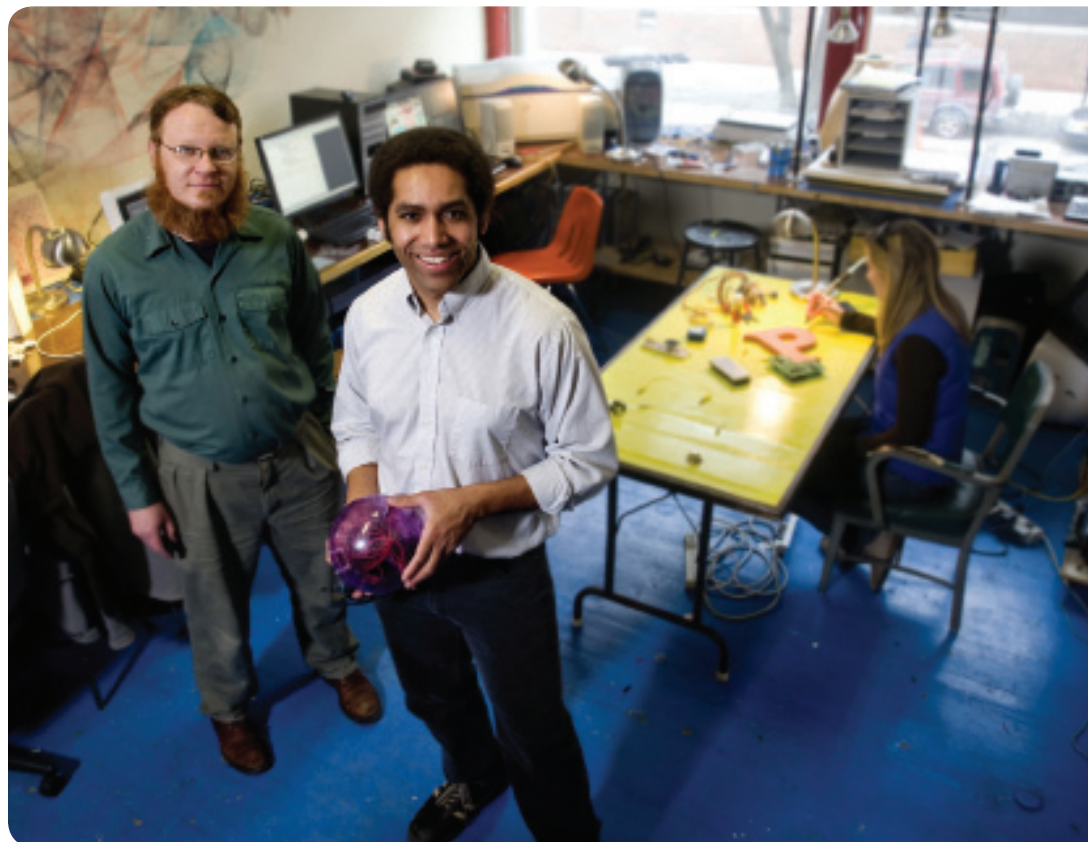

#### **Tax incentives** *continued from front*

- ⇒ RI Apportionment Exclusion - Medical/Pharmaceutical Manufacturers
  - ⇒ RI Accelerated Amortization for Defense Industry Manufacturers
  - ⇒ RI Investment Tax Credit for certain Non-Manufacturing Firms
  - ⇒ RI Research & Development credits, Property Credits, Elective Deduction for facilities, Sales Tax Exemptions, Specialized Stock provisions for software developers
  - ⇒ RI Corporate Income Tax Reduction for job creation
  - ⇒ RI Job Training tax credit up to 50% training expenditures
  - ⇒ RI Adult Education tax credit up to \$300 per employee, max.\$5,000 annually per employer
  - ⇒ RI Small Business Capital Investment Tax Incentives (deductions/modifications, capital gains exclusion, wage credits)
  - ⇒ Federal HUB Zone
  - ⇒ Financial Service Industry Incentives (Alien Insurance Companies, Deregulation of Commercial Lines, Gross Premiums Tax Credits in Enterprise Zones, Income Apportionment, Insurance Company Retaliatory Tax Exemption, etc.)
  - ⇒ Miscellaneous tax credits and incentives (including bonus program, child/adult day care tax credits, hazardous waste facilities amortization)
- And numerous RI Sales Tax Exemptions for certain types of business.
